S.D. 1732(E).- In exercise of the powers conferred by section 169 of the Representation of the People Act, 1951 (43 of 1951), the Central Government, after consulting the Election Commission, hereby makes the following rules further to amend the conduct of Election Rules 1961, namely:-

- (1) These rules may be called the Conduct of Election (Amendment) Rules 2012.
 - (2) They shall come into force on the date of the publication in the Official Gazette.
