This difference resulted in a discrepancy between the amount we recorded and the amount recorded by the shadow register.

The difference to the tune of Rs 124207/- is noticed, in which an amount of Rs. 150267/- was recorded in the Shadow Observation whereas an amount of Rs. 26060/- only was mentioned in the Register of Expenditure maintained by you.

It was also noticed that an amount of Rs 12000/- was transferred to the personal account of the candidate from the account meant for election expenditure on the 4th February 2023, which is not permitted as per the ECI instructions.


