- 3. The Container Trucks, will be fitted with GPS facilities.
- 4. Rates are to be quoted specifically only for "Two Categories", i.e., Category-I (DC Offices of Tura/Ampati/Resubelpara/Williamnagar/Nongpoh) in single rate and Category-II (DC Offices of Khliehriat/Jowai/Shillong/Mairang/Nongstoin/Mawkyrwat/Baghmara) in single rate.
- 5. To ensure that the EVMs/VVPATs should be handled with utmost care & precautions to be taken to avoid any possible damage in any way.
- 6. To make all necessary advance arrangements, and to ensure immediate deployment of container truck(s) at any point of time and with adequate fuel.
